[SB 705](#) - Riddle, Jeanie(R) - Allows water and sewer corporations to make an application to the Public Service Commission to approve rate schedules outside of a general rate proceeding.

[SB 727](#) - Emery, Ed(R) - Requires that the comprehensive state energy plan be reviewed by the Division of Energy by January 1, 2019, and biennially thereafter, and updated if necessary.

[SB 730](#) - Wallingford, Wayne(R) - Establishes the Rate Case Modernization Act for gas corporations.

[SB 782](#) - Cunningham, Mike(R) - Extends surface mining permit fees sunset to 2024.

[SB 815](#) - Schatz, Dave(R) - Modifies the civil penalty for violating federally mandated natural gas safety standards.

TRANSPORTATION BILLS

[HB 1447](#) - [Eggleston, J.\(R\)](#) - Increases the membership of the Highways and Transportation Commission to eight commissioners.

[HB 1479](#) - [Brattin, Rick\(R\)](#) - Implements the Streamlined Sales and Use Tax Agreement and dedicates the resulting revenue to the State Road Fund.

[HB 1699](#) - [Quade, Crystal\(D\)](#) - Implements the Streamlined Sales and Use Tax Agreement and directs the savings created to certain funds.

[HB 1912](#) - [Brattin, Rick\(R\)](#) - Changes the laws regarding tax increment financing and transportation development districts.

[HB 2035](#) - [Trent, Curtis\(R\)](#) - Creates a fund dedicated to transportation projects from the revenue saved through lower tax credit redemptions.

[HB 2059](#) - [Ellebracht, Mark\(D\)](#) - Modifies provisions of sunshine laws relating to data exchanged on government-issued cell phones.

[HB 2091](#) - [Reiboldt, Bill\(R\)](#) - Authorizes, upon voter approval, a ten-cent tax increase on motor fuel.

[HB 2092](#) - [Reiboldt, Bill\(R\)](#) - Authorizes, upon voter approval, a ten-cent tax increase on motor fuel and twelve-cent tax increase on diesel fuel.

[HB 2135](#) - [Messenger, Jeff\(R\)](#) - Requires the director of the department of transportation to be appointed by the governor, subject to the advice and consent of the senate.

[HB 2147](#) - [Korman, Bart\(R\)](#) - Changes the law regarding taxation so that the top income tax rate is reduced over several years and the motor fuel tax is increased by a proportional amount to be revenue neutral.

[HB 2148](#) - [Korman, Bart\(R\)](#) - Changes the law regarding motor fuel fees.

[HB 2149](#) - [Korman, Bart\(R\)](#) - Changes the law regarding taxation to modify sales and use tax definitions and to increase the motor fuel tax by seventeen cents.

[HB 2150](#) - [Korman, Bart\(R\)](#) - Changes the laws regarding the highway patrol so that it is funded under the general revenue.

[HB 2153](#) - [Korman, Bart\(R\)](#) - Creates the Emergency Bridge Repair and Replacement Fund.

[HB 2207](#) - [Berry, T.J.\(R\)](#) - Allows the department of transportation to authorize, operate, and approve construction designs for transportation sensor systems.

[HB 2215](#) - [Brattin, Rick\(R\)](#) - Exempts state road projects from the prevailing wage law to the extent allowed

by federal law.

[HB 2268](#) - Reiboldt, Bill(R) - Modifies certain department of transportation reporting requirements.

[HB 2288](#) - Hannegan, Tom(R) - Allows counties, cities, towns, and villages to charge an additional \$1 fee on car rentals, with the proceeds to be used for road and bridge improvements.

[HB 2352](#) - Fraker, Lyndall(R) - Changes the law regarding county revenues dedicated to roads by expanding the purposes for which such revenues may be used.

[HB 2386](#) - Reiboldt, Bill(R) - Extends sovereign immunity to contractors and subcontractors of the department of transportation when the contractors are performing governmental services previously performed by the department of transportation.

[HB 2482](#) - Korman, Bart(R) - Allows th department of transportation to, by rule, adjust certain transportation fees by the percentage of inflationary increase or decrease.

[HB 2483](#) - Korman, Bart(R) - Establishes a "miles driven" fee to be paid at the time of registration of a motor vehicle with a model year of 2020 and later.

[HB 2484](#) - Korman, Bart(R) - Establishes the I-70 Regional Transportation District.

[HB 2485](#) - Korman, Bart(R) - Changes the law regarding motor vehicle decal fees.

[HB 2600](#) - Korman, Bart(R) - Establishes a miles per gallon-based vehicle registration fee.

[HB 2645](#) - Trent, Curtis(R) - Requires the Highways and Transportation Commission to consider the complete life-cycle costs of work in determining the lowest bid amount submitted for a contract.

[HB 2721](#) - Korman, Bart(R) - Creates various funds dedicated to transportation.

[HB 2722](#) - Korman, Bart(R) - Allows the highways and transportation commission to issue bonds or other indebtedness to finance or refinance the construction or reconstruction of the state highway system.

[HJR 74](#) - Messenger, Jeff(R) - Proposes a constitutional amendment to authorize the highways and transportation commission to construct toll roads and impose and collect tolls on interstates and four-lane roadways.

[HJR 83](#) - Messenger, Jeff(R) - Proposes a constitutional amendment to direct increased funding from motor vehicle registration fee adjustments for inflation to a farm to market fund, a port development fund, the state road bond fund, and the highway patrol.

[HJR 84](#) - Korman, Bart(R) - Proposes a constitutional amendment to authorize a four-tenths percent sales and use tax whose revenues will be dedicated to state highway uses.

[HJR 96](#) - Reiboldt, Bill(R) - Proposes a constitutional amendment to raise the motor fuel tax to twenty-seven cents per gallon.

[HJR 97](#) - Reiboldt, Bill(R) - Proposes a constitutional amendment to raise the motor fuel tax to twenty-nine cents per gallon on diesel and twenty-seven cents per gallon on all other motor fuel.

[HJR 102](#) - Corlew, Kevin(R) - Proposes a constitutional amendment to authorize the highways and transportation commission to impose and collect tolls on bridges and highways in metropolitan areas for the purpose of managing congestion.

SB 598 - Riddle, Jeanie(R) - Requires that the Department of Transportation utility corridor be 12 feet wide with the location determined by the State Highways and Transportation Commission.

SB 611 - Koenig, Andrew(R) - Among other tax provisions proposes to cut individual and corporate income tax and raise the motor fuel tax.

SB 617 - Eigel, Bill(R) - Modifies several provisions relating to taxation including raising the motor fuel tax by 6 cents.

SB 619 - Eigel, Bill(R) - Allows the Highways and Transportation Commission to issue bonds to finance transportation infrastructure projects in St. Charles County.

SB 734 - Schatz, Dave(R) - Increases the motor fuel tax from \$0.17/gallon to \$0.27/gallon.

SB 956 - Cunningham, Mike(R) - Modifies provisions of law relating to transportation infrastructure financing.

SB 984 - Wallingford, Wayne(R) - Specifies that the State Highways and Transportation Commission shall consider veteran-owned small businesses to be disadvantaged business enterprises for purposes of highway construction contracts and associated reporting.

SB 1036 - Koenig, Andrew(R) - Modifies provisions relating to sales and use tax exemptions.

SB 1050 - Schatz, Dave(R) - Modifies provisions of law relating to transportation.

SB 1090 - Hummel, Jacob(D) - Increases the motor fuel tax rate to \$0.19/gallon on gasoline and \$0.22/gallon on diesel fuel.

SJR 36 - Schatz, Dave(R) - Authorizes a sales tax for law enforcement on state highways.
